**A SPECIAL MEETING** of the Town Board of the Town of Day, County of Saratoga, State of New York, was held at the Day Town Hall, 1650 North Shore Road, Hadley NY on October 28, 2013.

The meeting was called to order by Supervisor Mary Ann Johnson with the following persons present: Councilman Preston Allen, Councilwoman Suzanne Denn, Councilman Charlie Dreyer, Councilman Jeff Gray and Highway Superintendent Scott York.

Supervisor Mary Ann Johnson passed out the revised 2014 Tentative Budget to those present with the changes that had been discussed at the previous 2014 Tentative Budget Workshop.

Supervisor Mary Ann Johnson requested input from the Board regarding various items in the budget that had not been discussed at the previous 2014 Tentative Budget Workshop. Councilman Jeff Gray inquired as to the amount the highway tax has increased recently. Supervisor Mary Ann Johnson replied that the highway tax does not usually increase more than .02 or .03 cents which amounts to approx. \$9.00 per tax bill depending on the size of the property. Supervisor Mary Ann Johnson pointed out that the Town of Day has the lowest tax rate in Saratoga County next to Edinburg.

Supervisor Mary Ann Johnson stated that the Day Town Board can go to a Public Hearing with the budget and then make changes, with the exception of public officials salaries, or continue to work on it.

Councilman Preston Allen suggested raising prices on recycling permits to increase revenue. Possibly \$10.00 a permit.

Supervisor Mary Ann Johnson stated that she will put price increase suggestion on the November 14<sup>th</sup> Regular Town Board meeting agenda.

**Motion**, made by Councilman Charlie Dreyer, seconded by Councilwoman Suzanne Denn, to take the 2014 Preliminary Budget to a **Public Hearing** at 7:00 pm on November 07, 2013.
