**A SPECIAL MEETING** of the Town Board of the Town of Day, County of Saratoga, State of New York, was held in the Day Town Hall, 1650 North Shore Road, Hadley, NY 12835 on February 27, 2024.

The meeting was called to order by Supervisor Diana Edwards at 9:30am with the following answering roll call: Councilman George Lembo, Councilwoman Cheryl Allen, Councilman Harry Brennan, Supervisor Diana Edwards and Highway Superintendent Leonard Allen.

Supervisor Diana Edwards spoke about adding a new position for a Laborer for the Highway Department. Full-time starting pay \$19.00/per hour with benefits. A special workshop was held on February 20, 2024 with the Town Board members and the Finance Committee members to determine if adding a position is warranted and that we have the funds available as it was not provided for in the 2024 budget. Councilman Harry Brennan asked if the Finance Committee had a chance to look into the funds again to make sure it was okay. Supervisor Diana Edwards said that it was discussed at the workshop meeting and the funds are available and the Highway Superintendent Leonard Allen will budget accordingly for 2025. Councilwoman Cheryl Allen the Highway Superintendent if the starting pay was correct at the \$19.00 an hour, Leonard did confirm that was correct.

Councilman George Lembo did thank Highway Superintendent Leonard Allen for his patience and professionalism on needing the additional Laborer for the town. Also, for answering all the questions that he was asked by the Town Board. Councilman Lembo said he appreciated Christina Siebert as well from the Finance Committee who put time in to help figure out the financial part for the Laborer position.
